#### ~ NEW SHOOTERS ~

You do NOT need any fancy gear or guns to start shooting these matches. Just bring your duty handgun, four magazines, holster & magazine pouch, or service revolver, speed-loaders and pouches. There is nothing to memorize, the course will be announced as you shoot just like the stages during a qualification and fellow officers will gladly help you out. You can even use your stock duty gun to fire the Open Class Division Matches if you have four magazines. This will let you see what the other matches are like and how challenging and fun these matches are.

## Dates: Friday May 20th & Saturday May 21st

Fire either day or both days.

Location: Monroe-Chester Sportsman Club 224 Gibson Hill Rd. Chester, NY 10918

**Directions:** Route 17 west to Exit 130. Make a left at the light. Go past the first gas station and bear right to the next light. Make a left at the LIGHT. Go two lights to Route 5, Lakes Road. Make a right on Lakes Road. Go approximately 3 miles to Laroe Road (at the end of the lake on your left, follow the hospital signs to range). Make a right on Laroe Road and go to Gibson Hill Road, approximately 1.5 mile. Make a left on Gibson Hill Road. Range is on the right hand side, in approximately 1 mile.

**Matches Offered:** Service Weapon Match (Revolver and/or Semi-Auto) and Tactical Matches. No off-duty match will be offered.

**Governing Rules: Safety First, Last and Always!!** NRA service gun rules apply to the service weapon matches. See **ppc.nra.org**.

**Eligibility:** Law Enforcement and Civilians with full carry permits welcome. NRA Membership is not required for any NRA competitions but is encouraged.

#### **Event Fees:**

<u>Service Weapon</u>: \$10.00 per relay fired. Maximum of four scores may be fired for the two day event. Only the first score counts for match awards. Subsequent scores count for NYPCA annual awards only.

<u>Tactical Match:</u> Tactical match fees will be determined by participation and will be collected the day of the event. We anticipate multiple presentations over the two day event.

**Registration:** Advanced Registration is recommended as there are only be 15 shooters per relay with those who register in advance having priority squadding over walk-ons. No mail-in registrations! All squadding will be done by telephone or email.

On-site Registration and Check-In of Advanced Registration competitors will begin at 0915 the day of the Tournament. Make sure you allow time to register and get your gear together prior to the 1000 first match start time.

**Match & Relay Schedule:** The first match will begin at 1000 with the NYPCA Service Weapon Match. Up to 3 relays will be offered as participation demands. The Tactical event will follow.

**Targets:** Official NRA B-27 targets will be used for the service gun match. Tactical match scenarios will be a surprise! See you there!!

**Scoring:** Competitor scoring will be used. Pursuant to PPC Rule 14.2, **NO** competitor may score their own target NOR may a competitor score the targets of a competitor from their same agency. If this cannot be avoided due to the Relay's makeup contact a Tournament Official to score the targets.

PPC Rules prohibit the use of plug-type scoring gauges. Overlays and Eagle Eyes may be used by competitors. Score cards must be signed and are FINAL once signed so **PLEASE** double check the recorded hits and values BEFORE signing.

**Result Bulletins:** Final Result Bulletins will be provided via email.

**Lunch:** Food and drink will be provided for competitors.

**Awards Schedule: This is a no-frills match**. Scores count for NYPCA annual awards only.



# EYE AND EAR PROTECTION MUST BE WORN BY ALL COMPETITORS AND SPECTATORS

Time Limits: Time Limits will be announced for each stage or match. Time will start with loaded gun in the holster. No part of the competitor's hand may touch the gun until the command to commence firing is given.

Firing Method: Matches or stages designated as double action must be fired double action. Matches or stages designated as single action may be fired either single or double action. All double action semi-automatic pistols must fire the first shot of every stage double action except at the 50 yard line.

Loading: To force reloading under time restraints and magazines are loaded with a maximum of 6 rounds. There is no limit on the number of magazines or speed-loaders you have but after initial loading all ammunition used during the firing of a stage or string MUST be on your person.

#### Course of Fire information:

#### Service Weapon Match:

**Stage A:** 6 rounds in 8 seconds one handed (strong hand only) from 3 yards.

**Stage B:** 12 rounds standing without support in 20 seconds from 7 yards.

#### **TARGET CHANGE**

**Stage C:** 12 rounds standing without support in 20 seconds from 15 yards.

**Stage D:** 18 rounds – 6 rounds kneeling, 6 rounds standing left hand barricade, 6 rounds standing right hand barricade in 90 seconds from 25 yards. Ther barricade must be used for cover and support for all rounds fired!
