Call to Order 10:30am by Steve Albanese

**Steve** noted no one is squadding properly so it is not possible for the match sponsors to estimate food and water needs, making it cost more because they overbuy.

- Some people come from out of state.
- Club equipment worked fine
- The request is to run the Regional Match around Memorial Day (not on that weekend), and as natural lighting is an issue after September, State Championship just after Labor Day.

Extensive discussion on fees, costs, and awards for each match sponsor. Costs for competitors, ammo, gas, match fees, all add up

Discussion included point that sport is dying as demographics are changing- cash awards as incentive are ludicrous based on what costs are borne by the competitors.

- Notes also the \$4.00 for every 600 sent to NRA as an additional cost
- Rule (bylaws change) tactical and service do not have to be combined. They can be separate or combined. It's the sponsors option

Steve notes new shooters need NRA classification scores on 600 match, send in fees

• Service gun fees not sent to NRA because of need for standard gun and ammo specs. Many shooters do not use appropriate gun

Chris notes sending money to NRA is important for scores to go in, important to get guys classified

**Manny** – notes awards are important so competitors get something for their efforts, regardless of size or value

**Tim K** -NYPD pays MCSC on his own for range use, wants it to be a flat fee. No specific fee is set but donates \$100/match to club – Match Sponsors to pay fees to MCSC directly

# Calls to vote on fees, etc.: Steve Albanese seconded by Chris Story

- 1. All match sponsors send appropriate fees to NRA for 600 classification \$4/shooter. No Service, Tactical or any other matches scores/fees to send to NRA- **PASSED**
- 2. Money awards, if any, left to discretion of match sponsors- PASSED
- 3. Left to match sponsors to provide food- match scores sent to association to determine annual awards (end of year) **PASSED**
- 4. At every match, sponsor to send \$2.00 per shooter per day (this sentence revised) regardless of shooter's membership to NYPCA. These fees are where the Association get funding for annual awards **PASSED**
- 5. The designation of Off Duty Gun will be changed to "OPEN" and same course of fire as Service. The call for any centerfire gun allowed, including optics, approved with CM voting NO. **PASSED**

Whether the matches will be 600 or 1500- Association will follow NRA guidelines for 2023, will keep Off-Duty for all NRA certified matches- Regional & State Championship

NYPCA sends MCSC donation for NYPCA sponsored matches- LJ noted last year was \$1,000. Expect same amount for 2022.
